#### A REMINDER



It is against city ordinance to park on the street between the hours 1:00am and 7:00am from November 1 through March 31. Street parking is also prohibited by city ordinance 8-6-2008B under the following conditions

- When snow is falling
- When there is a visible amount of snow on the street
- When the snow has not been plowed from the last snowfall
- During city snow and ice removal

We continue to have issues with people not cleaning up after their dogs and not keeping them leashed at all times when outside.

- A gentle reminder you are responsible for cleaning up after your pet. There are several stations in our community with bags and bag disposal containers.
- The HOA has been getting many complaints about these issues and wants us all to be aware that homeowners/tenants are within their rights to send videos from their exterior cameras to animal control. Animal control does not have to be at your property to witness the violation, they can cite you based on the exterior camera evidence.
