# **Discussion Points**

- Walker joined to discuss parking. - Katie brought up the cement pads where the rocks are at the end of Lily Pad. Rich will get bids.

- Dan brought up the fence down by Katie's/Lily Pad. Brought up getting a bid for a replacement wall.
